1 INTRODUCTION

The Government of Northwest Territories (GNWT) – Department of Infrastructure (INF) retained Associated Engineering (B.C.) Ltd. (Associated) to prepare an engagement plan for the infrastructure upgrades (the project) at the Inuvik Mike Zubko Airport (Inuvik Airport), located approximately 12 km east of Inuvik, NT. The project includes necessary upgrades to the drainage system that will change the paths and discharge locations of runoff, and requires a Type B water licence to be issued from the Gwich'in Land and Water Board (GLWB) under the *Northwest Territories Waters Act* (SC 1992, c. 39) and regulations. The GLWB issued Type B Water Licence G23L8-002 (the licence) on September 23, 2023, and approved Version 1.0 of this engagement plan.

The purpose of this engagement plan is to summarize the engagement activities completed as a component of the water licence application submission to the GLWB and to detail the continued approach to engagement now that the licence has been issued.

1.1 Background

Before the start of the infrastructure upgrades project, GNWT-INF and Associated conducted early engagement activities related to the infrastructure upgrades at the airport with Indigenous Knowledge holders, local community members, businesses, and contractors in 2020 (Section 3.1).

The GNWT-INF requires a Type B water licence to be issued by the GLWB under the *Northwest Territories Waters Act* (SC 1992, c. 39) and regulations to complete drainage upgrades at the Inuvik Airport due to the "deposit of waste" (e.g., total suspended solids) trigger from run-off. The GLWB requires that pre-application engagement be completed with the potentially affected parties.

Transport Canada's *Canadian Aviation Regulations*, SOR/96-433 (CAR) require that pre-consultation be completed for a period of 45 days before proceeding with the runway extension. The pre-consultation activities for the runway extension were combined with the pre-application engagement activities for the drainage upgrades, which is why the list of potentially affected parties includes organizations that may not be concerned with the drainage upgrades. Under the CAR, a summary report must be submitted to Transport Canada. Details of the engagement activities completed specifically for the CAR are not included in this engagement plan, unless they were also relevant to the water licence pre-application engagement activities.

1.2 Engagement Objectives

The engagement process was guided by the following objectives:

- Increasing the potentially affected parties' understanding of the civil infrastructure upgrades and runway extension at the Inuvik Airport;
- Obtaining feedback from potentially affected parties on the upcoming drainage upgrades and runway extension and to provide an opportunity for potentially affected parties to ask questions; and
- Fulfilling the GLWB pre-application engagement requirements.

2 POTENTIALLY AFFECTED PARTIES

The GLWB and the Gwich'in Tribal Council provided input into identifying the potentially affected parties for the Inuvik Airport water licence application in 2023. These parties include local Indigenous organizations, surrounding

communities, and users of the Inuvik Airport (Table 2-1). Select potentially affected parties were identified as primary potentially affected parties, based on proximity and likelihood of potential impacts. Note that GNWT-INF may engage with other parties, as appropriate.

3 PRE-APPLICATION ENGAGEMENT APPROACH

3.1 Early Engagement Activities

Early engagement for the airport civil infrastructure upgrades began in 2020 that included an open house presentation, an informal coffee conversation with Elders, and a meeting with local contractors. The early engagement activities are summarized in Table 3-1. Engagement activities related to the drainage upgrades for the water licence application are discussed in Section 3.2.

3.2 Pre-application Engagement Activities

The pre-application engagement activities are summarized in Table 3-2. The engagement period for the water licence application was open for 21 days, from March 2 to March 23, 2023.

3.3 Engagement Record

A detailed engagement record for pre-application engagement activities, following the GLWB template, is provided in Appendix A. Note that the engagement record includes attachments, such as the full list of email addresses that received the notification letter, the newspaper announcement, and the record of meeting from the virtual information session.

A summary of the engagement activities conducted each year under the licence will be included in the annual reports, as required under Schedule 2 of the licence. The engagement record will not be updated each year with the engagement activities conducted post-issuance of the licence.

3.4 Engagement Outcomes

Feedback received during the virtual information session included questions about the following topics:

• Targeted submission date of the water licence application;

- Material availability in the quarry;
- Asphalt paving schedule;
- Earlier engagement activities; and
- A question about what a check dam is.

A copy of the record of meeting is included in the Engagement Record in Appendix A.

The Inuvialuit Environmental Impact Screening Committee responded by email on March 23, 2023, indicating that it did not have comments at the time.

Neither GNWT-INF nor Associated received any other responses.

4 WATER LICENCE ENGAGEMENT APPROACH

The GNWT-INF believes that meaningful community engagement is crucial in building and maintaining good relationships with communities and community members. The GNWT-INF regional offices are open for residents to provide comments and concerns, or to ask questions regarding GNWT-INF activities. As a result of the Department's open lines of communication, well-established relationships have been built with the people and communities of the Northwest Territories.

4.1 Activities That Will Prompt Engagement and Engagement Approach

GNWT anticipates that engagement will continue after the water licence is issued. A summary of potential activities that will prompt engagement and the proposed methods of engagement are provided in Table 4-1.

The Government of Northwest Territories – Department of Infrastructure (GNWT– INF) would like to advise you that the GNWT-INF is completing infrastructure upgrades and constructing a 914-metre runway extension at the Inuvik Mike Zubko Airport (Inuvik Airport). Notably, this project includes necessary upgrades to the drainage system that will change the paths and discharge locations of runoff from the Inuvik Airport and upland areas.

This work requires submission of an application for a Type B water licence to the Gwich'in Land and Water Board (the Board) and pre-consultation under Transport Canada's Canadian Aviation Regulations, Section 307.

The GNWT-INF understands the importance of engaging with any potentially affected parties. Early engagement related to the infrastructure upgrades at the Inuvik Airport was done in 2020 and took place as informal meet-and-greets with Indigenous Knowledge holders, an open house presentation for local residents, businesses, and contractors, and a meeting with local contractors.

This notification formally initiates the engagement process for the water licence pre-application related to drainage upgrades at the Inuvik Airport and the preconsultation process for the runway extension. The purpose of the engagement is to provide the interested parties with information on the project and give them an opportunity to provide input and ask questions.

1 PROJECT DESCRIPTION

1.1 **RUNWAY EXTENSION**

The upgrades to the infrastructure and runway at the Inuvik Airport include the following:

- Extending Runway 06-24 by 914 metres, including aircraft turning bays at each end of the runway;
- Resurfacing the existing runway, taxiway, and apron pavements;
- Relocating Nav Canada facilities;

- Improving airfield lighting and electrical systems;
- Implementing new pavement markings;
- Widening the runway safety area to meet current Transport Canada standards;
- Widening Taxiway C to accommodate larger aircraft (Aircraft Group Number IV);
- Improving airport stormwater drainage so that it directs runoff away from runway and taxiways and prevents standing water from negatively affecting the permafrost; and
- Developing climate design information for the runway that considers climate change.

Figure 1 (attached) shows the existing runway footprint, and Figure 2 (attached) shows the proposed runway extension.

1.2 DRAINAGE

The drainage upgrades at the Inuvik Airport will involve constructing new ditches and culverts at the airport and to the east and west of the airport in commissioner's land held under a reserve by the Inuvik Airport and within property boundaries held by GNWT Department of Lands.

Currently, rain and snowmelt runoff from the airport surfaces and surrounding land drains to Chii Zhìt Van (Dolomite Lake) and East Lake. The new drainage ditches will change the paths of some of this runoff and where it enters the lakes.

The existing drainage system does not function in its current condition. Runoff does not drain properly and forms areas of standing water, which causes the land around the runway and taxiways to sink. The existing drainage system is not adequate for the current development and climate conditions, and its performance would continue to degrade as climate change effects increase and as the airport is improved and further developed.

1.2.1 Existing Drainage System

Currently, runoff flows along the existing drainage paths and enters the lakes at locations called outfalls (OF), as follows:

- Through a natural drainage path west of the main quarry that drains to Dolomite Lake (OF_01);
- Through a natural drainage path on the east side of Public Quarry Road that drains to Dolomite Lake (OF_02);



- Through a natural drainage path east of the airport that drains around Runway 24 and then south to Dolomite Lake (OF_03); and
- Directly into East Lake (OF_04).

Figure 1 shows the existing drainage conditions and outfall locations at the Inuvik Airport.

1.2.2 Proposed Drainage System

Defined ditches will be constructed to transport runoff outside the airport property. The drainage design focuses on preventing standing water around the runway, taxiways, and related facilities in the long term. Standing water in these areas could impact the stability of the runway and embankments, and the support facilities, such as buildings. The proposed drainage paths and outfall locations are as follows:

- Runoff that used to flow over the Public Quarry Road to OF_01 will be diverted south, to OF_02, which will reduce the flow to the natural drainage path west of the quarry and increase the flow at OF_02;
- The ditch on the east side of the Public Quarry Road will be realigned to drain approximately 175 m east of the Public Quarry Road to avoid needing to blast into the existing bedrock (OF_02); and
- Stormwater that used to flow to Dolomite Lake from OF_03 will be diverted to East Like by the newly constructed OF_04, which will increase the flow to East Lake.

Figure 2 shows the proposed drainage ditch alignments and outfall locations.

The design of the ditches addresses the water quality of the runoff. The ditch design incorporates the following erosion control measures:

- Ditches will be armoured with screened rock over non-woven geotextile in sections where water velocity will be greater than 1 metre per second (m/s);
- Gabion basket check dams, which are rocks typically encased in wire mesh, will be installed at intervals where water velocity will be greater than 2 m/s;
- A screened rock apron will be installed around the culverts;
- Gabion baskets will be installed at the end of the two new outfall locations and will be placed approximately 3 metres above the ordinary high-water mark of both lakes; and
- Where screened rock is not required, ditches will be hydroseeded with a native grass mix.

The contractor will need to comply with the contract environmental specifications, which will include developing a construction environmental management plan. This plan will include an erosion and sediment control plan, a requirement to monitor



water quality during construction (such as turbidity, which is the cloudiness of the water), and a spill contingency plan.

2 WATER LICENCE

The Inuvik Airport has been operating without a water licence; however, the Board and GNWT Environment and Natural Resources have identified that a water licence is required to complete the drainage upgrades and for normal operation of the airport. The water licence *may* specify:

- The quality of runoff water that may be released to the environment (e.g., total suspended solids); and
- Terms and conditions for constructing the drainage ditches and operating conditions of the Inuvik Airport, such as requirements for water quality monitoring and plans for erosion and sediment control and spill contingency.

The documents that will form part of the water licence application for construction and operation of the airport include the following:

- Drainage design drawings
- Sediment and erosion control plan
- Waste management plan
- Spill contingency plan
- Stormwater monitoring plan

3 PROJECT TIMELINE

The GNWT–INF anticipates completing the pre-application engagement for the water licence by the end of March 2023 (21 days after this notification letter is sent) and the pre-consultation process for the runway extension by mid-April 2023 (45 days after this notification letter is sent). The GNWT–INF plans to submit the water licence application to the Board by the beginning of April 2023. If it is successful, GNWT–INF anticipates that the Board will issue the water licence between June and July 2023.

The construction of the runway extension is anticipated to begin on May 1, 2023, and be completed by December 30, 2027. Construction of the drainage improvements is anticipated to begin on August 1, 2023, or after the water licence is issued, and be completed by September 30, 2024.






Edmonton facility aids Elders and others traveling to city for treatment

By Eric Bowling

Medical problems can be scary, particularly as we get older and especially in remote parts of the country like the Beaufort Delta where emergencies usually require a trip to Edmonton for treatment.

This only complicates matters, as many people are not used to, or prepared for, the crowded chaotic streets of the big city, making the whole process quite daunting. And if you happen to have mobility or other health issues, it can be overwhelming.

overwhelming.
Enter Larga House, a joint venture by the Gwich'in Development Corporation, Nunatsi-

aq Corporation and Kitikmeot Corporation, to provide Elders and Northerners with as many comforts as they can while staying down south.

"There's some some Elders that are well versed ... and quite comfortable coming to the city," said general manager Jenn Wilkinson. "And then there's some that may be a bit more anxious. If they require more assistance, or they just want to talk to people more, we're here to take care of them.

"We pick up at the airport, we bring them here and get them accommodated and settled. We also take them to all of their appointments, pick them up from appointments and make sure that they're comfortable. Maybe they don't have equipment with them to travel, maybe they need a walker or wheelchair — we would provide that, make sure that we have that available for them as well."

Located a short walk away from the Royal Alexandria Hospital in downtown Edmonton, Larga House aims to be a home away from home for Northerners.

It also allows many who have moved south for work, education or other opportunities to keep in touch with their roots. Some staff have been working at the facility for up to 30 years. Many have family connections with guests from up North.

"You can often hear staff on the phone saying things like 'I love you too,' —it's very meaningful for people," said Wilkinson. "But not only that, people will see other people that they grew up with in other communities. So you'll see guests connect and they'll say things like 'I haven't seen you since I was a little girl.' I think that's pretty cool."

Sporting an elevator, a fully staffed kitchen providing free breakfast, lunch and dinner daily, a prayer room and kitchenettes for those

who would like to cook for themselves, there is room for up to 56 people at any time in the building.

Wilkinson said on average of 400 to 600 guests a month, and that was steadily increas-

Because of the close connection staff have with their guests, Wilkinson said the staff of Larga House were happy to go the extra mile to assist guests. From picking patients up at the airport to helping Elders with mobility issues around the city to getting emergency items ranging from toothbrushes to medication, the services offered to those in need are endless. Guests are given a survey at the end of their stay to provide feedback on what they liked and what can be improved, and Wilkinson said guests can raise concerns with staff at any time.

Making the medical travel experience a more friendly experience with familiar faces also provides emotional support for guests, noted Wilkinson, as many Elders who come down get a chance to see old friends and relatives they may not have seen for some time.

"If you talk to a majority of staff that work here, a lot of them will say they've come here for this reason, because they want to provide services to people from home," she added. "It absolutely makes a difference for somebody's grandma, grandpa, uncle, aunt, sister or brother. I think people feel more appreciated being provided services by people that they know from their communities.

"These hospitals have more people in them in than in some communities, at least some that I've lived in. So it's really overwhelming. I think when guests see people from home they know they're going to be looked after and be cared for. People here understand."




Canadian Aviation Regulations, Section 307.04 (1): Runway 06-24 Extension

To: Inuvik (Mike Zubko) Airport Stakeholders

The Government of Northwest Territories (GNWT) is completing infrastructure upgrades and constructing a 914-metre runway extension of Runway 06-24 at the Inuvik Mike Zubko Airport (Inuvik Airport).

Work to be completed includes:

- Extending Runway 06-24 by 914 metres, including aircraft turning bays at each end of the runway, to increase the capability of the airport
- Resurfacing the existing runway, taxiway, and apron pavements to increase airport efficiency
- Improving airfield lighting and electrical systems
- Implementing new pavement markings
- Widening the runway safety area to meet current Transport Canada standards
- Widening Taxiway C to accommodate larger aircraft (Aircraft Group Number IV)
- Improving airport stormwater drainage so that it directs runoff away from runway and taxiways, and prevents standing water from negatively affecting the permafrost
- Developing climate design information for the runway that considers the impacts of climate change.

This work requires submission of an application for a Type B water licence to the Gwich'in Land and Water Board, and pre-consultation under Transport Canada's Canadian Aviation Regulations, Section 307.

Early engagement related to the infrastructure upgrades at the Inuvik Airport was done in 2020 and took place as informal meet-and-greets with Indigenous Knowledge holders, an open house presentation for local residents, businesses, and contractors, and a meeting with local contractors. The purpose of this engagement is to provide interested parties with information on the project and give them an opportunity to provide input and ask questions.

Project Schedule

Runway construction is anticipated to begin May 1, 2023 and be completed by December 30, 2027. Drainage improvements are anticipated to begin August 1, 2023 (or following issue of the water license) and be completed by September 30, 2024.



Project Scope

- Runway extension grading, granular base, and pavement structure using fill obtained from airport quarry including aircraft turnarounds at each end of the runway
- Resurfacing existing runway, taxiway, and apron pavements, and pavement markings
- Airfield drainage system improvements, relocation of Nav Canada facilities, and airfield electrical system & lighting improvements
- Widening Taxiway C to accommodate larger aircraft (AGN IV)
- Widening runway safety area to meet current Transport Canada requirements

Project Scope con't

- Thermal analysis of the extension area completed to determine the potential impact to the runway extension over the next 50 years.
- Design and construction sequence consider mitigative and adaptive measures for the protection of the permafrost regime below the runway extension and strip surface.
- Drainage solution to the problem of an existing dip in the Taxiway E surface near the runway.

Project Scope con't

- Direct surface drainage away from runway and strip infrastructure and prevent ponding water from impacting the permafrost regime.
- Establish proper drainage channels to accommodate changes in hydrology both within and beyond airport boundaries
- Establish drainage outfall structures to slow velocity and increase water quality before discharge








Water License Application

- Drainage system improvements require realignment of ditches and culverts to maintain proper airfield drainage and avoid standing water
- The Airport does not currently hold a water license
- A water license application is being submitted to address a change in flow patterns and ensure environmental regulatory requirements are met

Water License Application

- The drainage design includes several erosion control measures:
 - Ditch armoring
 - Check dams
 - Screened rock culvert aprons
 - Outfall structures
 - Hydroseeding
- Temporary erosion and sediment control measures and water quality testing will be implemented during construction

Water License Application

- Work which may impact water quality released directly to the environment (such as new ditches and outfalls) will be completed after the water license is issued
- The water license may also dictate:
 - Construction staging limitations
 - Additional or more frequent water quality testing
 - Spill contingency requirements
