We are occupiers of the Great Slave Sailing Club (GSSC) property by virtue of our membership in the club of over 32 years.

We launch our 26 foot sailboat into Back Bay and retrieve it from Back Bay by 100 ton crane (Canuck Crane) from the GSSC property. On occasion our mast requires removal and replacement and that is done by crane in the water at the dock of the property. We maintain a mooring in the mooring field in the waters adjacent to the property. We access our boat in the mooring field by dinghy from the property. We participate in the cruising and social activities of the club. We perform maintenance on our boat at the dock on the property.

We make use of the property from early June until mid-October of each year. Typically, the launch of boats occurs during the first weekend of June and the retrieval of boats in mid-September. On shore maintenance is performed in May, September and early October. Ordinarily the mast need not be removed as the boat remains in the yard.

Our boat is a Morris Yachts Frances 26; it weighs 12,000 lbs, is 8'2" wide and has a mast 40 feet in height. It draws 4 $\frac{1}{2}$ feet of water.

During the autumn/winter/and spring our boat sits on a metal cradle at the GSSC boat yard. The boat and cradle cannot be transported unless they are loaded onto an appropriate trailer.

The cost for a trailer of the capacity required is estimated to be \$13,500, including GST (2019 retail cost – Flaman Trailers Edmonton). Our boat cannot be transported on land with the mast installed. Our mast is not normally removed for storage. Depending on conditions the cost of mast stepping or removal is estimated to double the cost of a normal launch or retrieval cycle.

A plan is being developed which may reduce the impact on the club and the public while still achieving the goals of remediation. The plan has been quickly evolving over the past few weeks through a meeting with Giant Mine Remediation Committee and a meeting with the GNWT. Complications may extend the times intended by a season. This claim is being made roughly on the basis of recent meetings with DIAND (GMRC at the Scotia Centre) and with the GNWT at the sailing club, the outcomes of which indicated the possibility of limited disruption to the club and member operations.

In summary we understand that the many of the club's sailboats may be moved to higher on the property or within a short distance of the property for 2 or more winters while remediation to the land and shoreline is conducted plus the construction of a boat launch. The club boats may launch for one or two seasons from the public dock. Once remediation of the GSSC property is complete, sailboats can return to the club yard and launch as normal from there. The public would also be accommodated through access to the new boat launch ramp facility on the club property while the public dock and boat launch is unavailable due to remediation. A best-case scenario is local relocation of boats, trailers and cradles for 21 to 33 months (in the event of complications) and launching, mast stepping and retrieving of sailboats at the public wharf for one or two summers.

From a review of the plans, we can discern access to the area will be totally denied while the construction is undertaken. Once complete we are assuming the work will be accomplished to the standard expected and only periodic monitoring will be undertaken but access will be available to the Sailing Club or others as approved.


