Hi Susan and Robert,

The Hamlet will require specific bottles (2 x 40 ml glass vials) for the Total Petroleum hydrocarbon analysis. Please request some of these sample bottles from Judy at Taiga. Some care will need to be taken when collecting these samples as there should be no air bubbles or trapped air in the vials. The cap will have a see through top to confirm whether or not air is present. I usually overfill the vials so that there is a meniscus of water on top, then put the cap

on. This technique works to ensure no air gets trapped inside the vial.

I'm assuming the Hamlet still has some of the 1 litre amber glass bottles used to collect the Oil & Grease samples. This same bottle can be used for the Extractable Hydrocarbon analysis. It won't require preservation. Just fill it up and cap it.

Please don't hesitate to contact me if you have any questions with regards to the above, or the sampling requirements noted below.

Sorry I missed you by phone - I am heading into a call at 2:30, and then leaving for the day at 3:00; I know you're eager to have this question resolved so that decant can begin.

So, Heather Scott (MVLWB Technical Advisor) and I talked over this situation, and would like to ask that you resample at SNP station 1412-2 prior to decanting. It would be helpful to know more information about the make-up of the high Oil and Grease content prior to decant, both for understanding potential impacts to the receiving environment, and hopefully also from an operational perspective (if substances are making their way into the lagoon that shouldn't be there).

Please sample again at SNP 1412-2 for Oil and Grease, as well as for Total Petroleum Hydrocarbons and Extractable Hydrocarbons. If you could please send results to both Wendy and I, that would be much appreciated.
