Hello Ruby,

Environment and Natural Resources advises that the decant of the Sambaa K'e sewage lagoon can proceed but we would like to confirm (i.e. photos) that the discharge location is suitable (e.g. not frozen) and you should discharge at a moderate rate to allow maximum attenuation in the receiving environment. You should not decant any more than you have to get back to safe operating levels.

In future, prior to Sambaa K'e sending samples to the lab, it should be made clear what samples are required as per the water licence and this should also be communicated clearly to the lab (along with the fact that they are rush samples).

Hopefully, ENR Dehcho Region will have a new Water Resource Officer in place soon who can better assist you with these matters.
