1. Introduction and Project Details

Government of the Northwest Territories Department of Industry, Tourism and Investment (further referred to as ITI) has developed this Engagement Plan (or Plan) for Improvements to the Prosperous Lake Territorial Park Boat Launch in accordance with the Mackenzie Valley Land and Water Board's Engagement and Consultation Policy (Policy) and the Engagement Guidelines for Applicants and Holders of Water Licences and Land Use Permits (Guidelines).

1.1. Project Description

Improvements to the boat launch will include:

- The addition of an additional floating dock and two launch ramps
- Refurbishment of the current boat launch ramp and dock

ITI anticipates the main construction to take five months, however until the new boat ramps settle, it is anticipated that some light maintenance and leveling may be required for up to five (5) years. During construction, the area will continue to operate as a Territorial Park, and will continue to operate as a Territorial Park for the foreseeable future.

GNWT ITI recognizes that the benefits of engaging are long-term and are an investment in achieving our vision of being a responsible and welcome member of the communities in which we operate.

This Plan will help ITI provide a means to share ideas, plans, and values while receiving input from affected parties about potential concerns and mitigations.



3. Affected Parties

ITI recognizes that not all potentially affected parties are the same and will be communicating the plan either by email, letter, in person or all three.


8. Implementing the Plan
