Explanatory Remarks

An inspection of the De Beers Canada Inc., Gahcho Kue Mining and Associated Activities LUP was conducted by Inspector Tom Bradbury on August 14, 2025. The inspection was carried out to ensure operating conditions annexed to the above-noted land use permit are being adhered to during this land use operation, while following up on previously noted concerns.

Site conditions have improved dramatically since the June inspection where a number of non-compliance items were highlighted as requiring mitigation (Photo 1). The Inspector is quite pleased with the turnaround of site conditions through the efforts of De Beers' contractor Nuna and the hiring of BluMetric for site assessment and sampling.

Observations At Site

Areas previously flagged for excavation by BluMetric have been sampled and final results will be provided by De Beers when received (Photos 2-3). Preliminary results have demonstrated that hydrocarbons are still present in two excavated sites, including the incinerator area (Photo 4).

Nuna personnel relocated vehicles for cleanup and maintenance purposes (Photo 5). Upon inspection all superficial spillage noted under vehicles, tanks, and open areas had been cleaned up to the Inspector's satisfaction (Photos 6-8). Spill pads have been replaced under all vehicles, and there remains no observable hydrocarbon staining on site or leakages from any equipment (9-10). A general reorganization and tidying of site was conducted by Nuna involving consolidation of debris earmarked for removal on the winter road, while decluttering of items such as totes and lumber was also noted (Photo 11-12). A total of 70 mega bags of hydrocarbon contaminated soil was collected from the cleanup of Margaret Lake camp by Nuna personnel over two site visits, which will shipped off site on the 2026 winter road (Photo 13).

Once De Beers provides the final sample results the Inspector can determine next steps, which will shift from cleanup to prevention for the upcoming operational season. This will occur through a work plan, and regular updates which will be determined through future discussions with De Beers and Nuna.

In conclusion, the Inspector is quite pleased with the response to the June inspection and the timeframe in which De Beers and Nuna were able to mitigate the non-compliances previously noted. Remarkable improvement can be demonstrated between the June through August inspection reports, and all parties are confident that the 2026 winter operational season will be a success!
