Issuance of Quarry Permit at Km 44.5, Highway No. 5

This letter is to inform you that the Government of the Northwest Territories (GNWT) Department (Department) is issuing a quarry permit at Km 44.5, Highway No. 5.

BACKGROUND

Ongoing quarrying is required at this location and the applicant is requesting a 3-year quarrying permit to remove 10,000 cubic metres of gravel. The most recent quarry permit that the Department issued to the applicant was on June 14, 2021, which is almost exhausted. It is important to note that the boundaries identified in this application are the same as previous applications and these same boundaries are not proposed to change.
