Re: Spill Contingency Plan – Version 1.2 – Approved – Yellowknife Lithium Project – Mineral Exploration – Yellowknife, NT

The Mackenzie Valley Land and Water Board (Board) received the Spill Contingency Plan, Version 1.2 (SCP V1.2)¹ submitted by EREX International Ltd. (EREX) on March 6, 2023 as required by the Board's January 3, 2023 Decision Letters on Version 1.^{2 3 4}

Board staff note that the SCP V1.2 was submitted with an Amendment Application that is currently out for review on the Board's Online Review System.⁵ In the Amendment Applications, EREX has applied to have a fuel storage area on federal land at the Hidden Lake Camp. Consequently, the Board directive about updating the SCP to include a confirmation that the Hidden Lake Camp will only store fuel that is needed for heating is no longer applicable. Please note that EREX cannot store fuel (besides what is needed for heating) at the Hidden Lake Camp until this activity is approved by the Board.
