Archer, Cathro & Associates (1981) Limited are writing to notify you of our intention to amend the Mackenzie Valley Land and Water Board (MVLWB) Land Use Permit MV2023C0002 to add claims K07736 to K07740 located within the Dehcho First Nation Traditional Territory. This amendment will be submitted within the next week now that the initial Mackenzie Valley Land & Water Board process for work in claims LI1 to LI3 is complete.

The newly staked Claims LI4-LI8 (K07736 to K07740) surround the existing LNPG tenure area, as submitted in January 2023. The scope and focus of work for this amendment will remain the same as is stated in application MV2023C0002 for the duration of the Land Use Permit. Attached is a map showing the recently staked claims.
