**RE: Annual Water Licence Reports**

Dear SAOs and Town Managers,

The Board would like to remind all Municipal Licensees, that the conditions of their Licences require submission of Annual Water Licence Reports by March 31 of each year. These reports are necessary for presenting data and information on the activities completed for municipal water and waste services. Most importantly, the sampling of the Surveillance Network Program monitoring stations is necessary to ensure that the Waste and Sewage Disposal Facilities are not contaminating the surrounding land and water.

Annual Reports are required to help keep all interested parties informed of the status of the facilities, the way Licence requirements are being met and as a mechanism to facilitate discussion toward resolving issues and concerns.

Please be advised that this letter will be posted as part of the Public Registry.
